# **Application Process**

The International Study Tours have limited places.

Your **Programme Director** will review all applications and allocate places on each Tour.

Application criteria is announced when the applications open, and at dedicated induction sessions.









Once your application is **approved**, you will be required to pay a fee of **£250**. This covers:

- Bed and Breakfast shared accommodation
- Cultural Activities
- International company visits
- Transport to/from visits
- Welcome Dinner
- Durham University standard travel insurance

Non-payment of the fee by the deadline will result in your withdrawal from the module







# What is NOT included

- **Travel** to/from destination
- Ensuring you comply with visa/travel permit requirements
- Visa applications
- Additional travel insurance (e.g. for dangerous sports, medical condition)
- Meals not stated in the itinerary
- Incidental expenses
