- 6. Excellent spoken and written communication skills including the ability to develop effective working relationships, both internally and externally.
- 7. Strong digital competence across a range digital devices and apps including internet, email, digital communication tools, Microsoft 365 applications, learning management system, e-learning authoring tools, digital booking systems, project planning, financial systems, recruitment tools.
- 8. Knowledge of eLearning design and management of systems.
- 9. Committed to continuing professional development to maintain professional recognition.
- 10. Knowledge and experience of ensuring compliance with regulatory and organisational policy and guidelines.
- 11. Ability to solve problems and decide on and plan appropriate solutions.

Service Delivery/Development
