Provider impact report

This impact report summarises the progress made by University of Durham against targets, objectives and written commitments set out in its 2019-20 access and participation plan. This document is a summary of information submitted by the provider to the OfS. This document is a self-report by the provider only and does not indicate any OfS assessment of compliance.

1. Ambition and strategy

University of Durham's ambition and strategy as detailed in the 2019-20 access and participation plan:

The 2019-20 Access and Participation Plan Durham drew attention to how strongly widening participation features in the University's ten year strategy and stated Durham's ambitions for addressing these challenges as follows:

• to generate applications from disadvantaged groups through highly targeted outreach activity;

• to adopt a holistic approach to assessment of merit and potential, including the use of information about the context of prior academic achievement;

• to ensure a high degree of academic and non-academic support to all students, but to be targeted towards at-risk cohorts where necessary;

• to focus on employability by offering opportunities to develop key skills and to engage with employers;

• to offer financial support packages to support access, success and progression where there is most need.

T16a_03	Following guidance from the OfS about future national measures of disadvantage, the proportion of Acorn 4/5 entrants is no longer a target in our 2020-2025 Access and Participation Plan, where the focus is on access from low participation neighbourhoods. That said, we will continue to use Acorn 4/5 as a validating condition for identifying disadvantage and eligibility for a contextual offer, and we will continue to monitor the percentage proportion metric internally in that context, building on the remarkable performance against this measure in 2021.
T16a_04	This Supported Progression conversion target does not appear in the Access and Participation Plan 2020/21 to 2024/25. The Supported Progression Scheme has changed and is now specifically focussed on delivery of POLAR 4 targets in the Access and Participation Plan 2020/21 to 2024/25. There is no longer a separate target for the number of participants in the programme converting to applicants. The aim of the refocussed programme is to engage participants who represent the most important targets of disadvantage, such as LPN. As a result the programme will be smaller in scale but more intense, and progressively more focussed on LPN. We are already beginning to see the success of this change in the proportion of LPN entrants among the participants who convert. Moreover, under the title 'Academic Safety Net', we are continuing with the most successful elements of the 2019/20 'No Detriment Policy'. Our detailed analysis, by student group, of degree outcomes and assessment performance directly informed this decision. We anticipate that the arrangements will benefit our target underrepresented groups.
T16a_13	This Supported Progression target does not appear in the Access and Participation Plan 2020/21 to 2024/25. That said, in the light of research into the effect on student success of contextual offer-making, we are becoming bolder in our use of contextual offers, which is allowing us to widen the pool of potential disadvantaged students to whom contextual offers can be made, including participants in the Supported Progression Scheme. We will continue to recognise potential and make further adjustments of offers consistent with research findings, that they will not compromise future success in students' programmes of study. In the light of this research, the initial contextual offer will be bolder and the need for further concession reduced.
T16b_02	The new digital offering, developed as a response to the pandemic, is a major enhancement to the programme which we hope will prove popular among the hard to reach key stages 3 and 4. At this level it is difficult for schools to create space in teaching timetables to enable a visit to Durham for on-campus activity. The digital offering is a very practical alternative.

Annex A: Commentary on progress against targets

University of Durham's commentary where progress against targets was less than expected.

Target reference number: T16a_03

How have you met the commitments in your plan related to this target?

We have met the commitments in the plan related to this target. Acorn 4/5 was a criterion used both for selection for access programmes and in the issuing of contextual offers. Compared with earlier Access Agreements, the target for 2019/20 was adjusted upwards because of the exceptional progress made against the original target in the 2017/18 Access Agreement. Further progress was made in 2019/20 but not quite as great as anticipated. It rose year-on-year by 0.63 percentage points.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

We increased the tariff differential in the use of guaranteed contextual offers to students in the ACORN classification target categories. As a result, the performance on this measure for 2020/21 was a remarkable 16.88%.

Target reference number: T16a_04

How have you met the commitments in your plan related to this target?

We have met the commitments in the plan related to this target. These were students who came through our programme in summer 2019, which had the highest number of participants since the programme began, but the conversion rate was lower and we missed the milestone by a margin of 11 applicants. As set out in our 2018/19 Access Agreement, we reduced the monetary value of the bursary attached to this programme in the light of research findings into the value of bursaries in supporting the success of students. However, this change did not take account of the value of the bursary as a recruitment incentive. Lower conversion rates from participation in the programme to application and enrolment were consequent on a reduced level of bursary.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

This target does not appear in the Access and Participation Plan 2020/21 to 2024/25. In the light of the national access POLAR 4 targets set by the OfS we have been redesigning our flagship access scheme to contribute towards the achievement of POLAR 4 targets. The original target for this scheme, as stated in the 2019/20 APP, measured the overall number of participants who subsequently applied to Durham rather than the extent to which those applicants represented the most important targets of disadvantage, such as LPN. The scheme is becoming more strategically aligned, smaller in scale but more intense, and progressively more focussed on LPN. So within two years, from 2017/18 to 2019/20, we have both nearly doubled the proportion of these applicants who are from LPN backgrounds, and increased the actual number of LPN applicants from this source.

Target reference number: T16a_05

How have you met the commitments in your plan related to this target?

We have met the commitments in the plan related to this target. These were students who came through our programme in summer 2018, which at that point had the highest number of participants since the programme began, but the conversion rate was lower.

As set out in our 2018/19 Access Agreement, we reduced the monetary value of the bursary attached to this programme in the light of research findings into the value of bursaries in supporting the success of students. However, this change did not take sufficient account of the role of the bursary as a recruitment incentive. Lower conversion rates from participation in the programme to enrolment were consequent on a reduced level of bursary.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

This target does not appear in the Access and Participation Plan 2020/21 to 2024/25. In the light of the national POLAR 4 Q1 access targets set by the OfS we have been redesigning our flagship access scheme to contribute towards the achievement of POLAR 4 targets. The original target for this scheme, as stated in the 2019/20 APP, measured the overall number of participants who converted to enrolments rather than the extent to which those enrolments represented the most important targets of disadvantage, such as LPN. The scheme is becoming more strategically aligned, smaller in scale but more intense, and progressively more focussed on LPN. So within two years, from 2017/18 to 2019/20, we have both nearly doubled the proportion of these entrants who are from LPN backgrounds, and increased the actual number of LPN entrants from this source.

Target reference number: T16a_08

How have you met the commitments in your plan related to this target?

We have met the commitments in the plan related to this target. We continue to have an excellent non-continuation rate, albeit just exceeding the 2% target in 2019.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

In the context of moves to online examinations in 2020 we were concerned about how to protect the interest of students, and introduced a suite of 'No Detriment' policies intended to counter any uneven effects of the pandemic. We subsequently looked at the assessment performance of students from under-represented groups compared with their cohorts which showed that our actions appeared to have been positive for students from those groups. We saw a narrowing of the gaps in the proportion of students achieving a pass mark and in mean marks.

How have you met the commitments in your plan related to this target?

We have met the commitments in the plan related to this target. The scheme supported the academic attainment of its participants. We made contextual offers to these students within

the range of what we then judged to be sufficient recognition of potential, based on the academic support and assessment during the summer school.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

In the light of research into the effect on student success of contextual offer-making, we are becoming bolder in our use of contextual offers, which is allowing us to widen the pool of potential disadvantaged students to whom contextual offers can be made, including participants in the Supported Progression Scheme. Further adjustments of offers are consistent with research findings, that they will not compromise future success in students' programmes of study. In the light of this research, the initial contextual offer will be bolder and the need for further concession reduced.

Target reference number: T16b_02

How have you met the commitments in your plan related to this target?

We have met the commitments in the plan related to this target. The large number of children and young people involved in Museums educational outreach activity relate to the first half of the academic year before the pandemic lockdown began and visiting became impossible.

Have you taken any additional steps other than that detailed in the plan to reach the selected milestone?

We have developed a digital version of the museum activity which is proving popular and allows us to reach schools beyond the region. As the pandemic eases we will be offering both face-to-face and digital activity.
